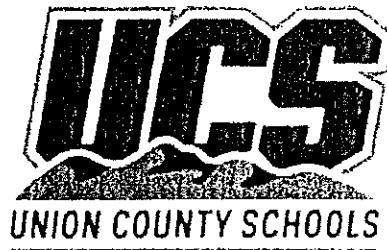

**PROGRAM POLICIES** - Parents/Guardians, please initial beside each policy.

\_\_\_\_\_ I understand that the expectations for good behavior in the afterschool program are the same as during the regular school day. All regular school day rules apply, including dress and behavior rules. Students who refuse to follow these procedures will not be allowed to continue in the program. Parents/Guardians will be contacted if a child misbehaves. Chronic misbehavior will result in dismissal from the program.

\_\_\_\_\_ I understand that transportation from the school will be provided for my child. Misbehavior on the bus can result in suspension from the bus, as well as from the after-school program. In the event that I choose to transport my child, I understand that I must pick him/her up **NO LATER than 5:00 PM** from my child's school. If I have not picked up my child at the designated time, we will attempt to reach emergency contacts; however, if we are unable to reach an emergency contact, the UCS Police office will be contacted. If my child is chronically late being picked up, my child may be dismissed from the program. If I am consistently late for pick up from the bus stop, my child will not be allowed to ride the bus.
